I/(WE), THE UNDERSIGNED, AGREE TO ALL OF THE FOLLOWING TERMS OF THIS CONTRACT AND UNDERSTAND THAT NON-COMPLIANCE WITH THE TERMS OF THIS AGREEMENT GIVES NORTH EAST AFGHAN HOUND RESCUE, INC. (NEAHR, INC.) THE RIGHT TO RECLAIM THIS AFGHAN HOUND, WITHOUT REFUND OF ADOPTION FEE.

1. To provide proper food, fresh water and shelter at all times. _____
(AGREE, ADOPTER INITIALS)
2. To treat the above named Afghan Hound as a family pet, with affection and kindness and not subject the Afghan Hound to abuse or cruelty at any time. To provide adequate companionship, including time in the house. _____
(AGREE, ADOPTER INITIALS)
3. When outside, I/(we) will always keep this dog on a leash or in a fenced yard. The dog will **NEVER** be left unsupervised or unattended on a cable run, tie-out or in the yard. _____
(AGREE, ADOPTER INITIALS)
4. To license the dog with the city/town Dog Officer within two weeks, to have identity tags within one month of adoption, and to keep a personal ID tag and Rabies Vaccination tag on the Afghan Hound, attached to a strong buckle collar, at all times. To **NEVER** leave a choke chain or collar on the dog when unattended.

5. To provide regular veterinary care, including annual vaccinations, parasite checks/controls and dental care. To have a heartworm test each spring, and keep this dog on heartworm preventative (type of preventative and schedule to be discussed with veterinarian). _____

6. To return the Afghan Hound **ONLY** TO North East Afghan Hound Rescue, Inc. (NEAHR, INC.) if unable to keep at any time during the life of the dog. Also, not to abandon, give away, take to a humane society, pound or shelter, or to sell this adopted Afghan Hound. _____

7. To notify North East Afghan Hound Rescue, Inc. (NEAHR, INC.) **IMMEDIATELY** IF THE Afghan Hound is lost or stolen and to make every effort to locate the Afghan Hound by contacting shelters, humane societies, and by placing ads in newspapers. _____

8. To notify North East Afghan Hound Rescue, Inc. (NEAHR, INC.) **IMMEDIATELY** if the Afghan Hound passes away for any reason. _____

9. Never allow the dog to be used in animal research. _____

10. To regularly groom and keep the coat brushed and free of mats or clipped. _____

11. For adoption placement of puppies only, to spay or neuter this Afghan Hound at or before six months of age.

12. To allow North East Afghan Hound Rescue, Inc. (NEAHR, INC.) to conduct follow-up calls and/or visits to insure that any and all Afghan Hounds placed are properly cared for and to determine that the terms and conditions stated in the Adoption Application and Adoption Contract are being met. _____

ADOPTER'S NAME

IF AT ANY TIME NORTH EAST AFGHAN HOUND RESCUE, INC. (NEAHR, INC.) DETERMINES THAT THE TERMS AND CONDITIONS OF EITHER THE ADOPTION APPLICATION OR THE ADOPTION CONTRACT HAVE BEEN VIOLATED OR FALSIFIED IN ANY WAY, OR THAT THE ANIMAL IS NOT RECEIVING PROPER AND HUMANE CARE, NORTH EAST AFGHAN HOUND RESCUE, INC. (NEAHR, INC.) MAY COME AND TAKE CUSTODY OF THE ANIMAL(S)**.

** IF MULTIPLE DOGS HAVE BEEN PLACED, NORTH EAST AFGHAN HOUND RESCUE, INC. (NEAHR, INC.) RESERVES THE RIGHT TO RECLAIM ANY AND ALL ANIMALS PLACED IN THE HOME, IF THE CONTRACTS NAMED ABOVE HAVE BEEN VIOLATED OR FALSIFIED FOR ONE OR MORE DOGS.

RELEASE AND INDEMNIFICATION: I/(WE) HEREBY AUTHORIZE NORTH EAST AFGHAN HOUND RESCUE, INC. (NEAHR, INC.) TO CONTACT MY VETERINARIAN AND LOCAL DOG OFFICER TO INSURE THE TERMS OF THIS CONTRACT ARE BEING MET.

IN CONSIDERATION OF NORTH EAST AFGHAN HOUND RESCUE, INC. (NEAHR, INC.) ALLOWING ME/(US) TO ADOPT THE AFGHAN HOUND AS OUR PET, I/(WE) PROMISE AND AGREE TO BE SOLELY RESPONSIBLE FOR THIS ANIMAL AND TO INDEMNIFY AND HOLD HARMLESS NORTH EAST AFGHAN HOUND RESCUE, INC. (NEAHR, INC.), AND ITS VOLUNTEERS FROM ANY AND ALL CLAIMS OR LIABILITY FOR THE CONDUCT OF THIS AFGHAN HOUND ON OR AFTER THE DATE OF THIS ADOPTION. THE UNDERSIGNED(S) FURTHER AGREE(S) AND INTEND(S) THAT THIS RELEASE OF LIABILITY AND INDEMNIFICATION SHALL APPLY TO ALL KNOWN, UNKNOWN, AND UNANTICIPATED DAMAGES RESULTING FROM MY/(OUR) ADOPTION, OWNERSHIP OR CONTROL OF SUCH ANIMAL. THIS IS A BINDING CONTRACT, ENFORCEABLE BY CIVIL LAW. I/(WE) HAVE READ AND AGREE TO ALL CONDITIONS IN THIS CONTRACT.
